ABOUT THE SESSION LEADERS

CHRISTOPHER L. OAKLEY is vice president and regional executive of the Jacksonville Branch of the Federal Reserve Bank of Atlanta. He is responsible for the Branch’s Board of Directors and the District’s Advisory Council on Trade and Transportation. Mr. Oakley oversees Jacksonville’s economic and financial education programs, and provides regional input into the Atlanta Fed’s monetary policy process. A native of Hendersonville, North Carolina, and raised in Dalton, Georgia, Mr. Oakley received his bachelor’s degree in management and a certificate in industrial and organizational psychology from the Georgia Institute of Technology. He has also participated in the executive education curriculum at the University of Virginia and the Federal Reserve System’s Senior Officer Development program.

LESLEY MACE is a Senior Educational Outreach Consultant at the Federal Reserve Bank of Atlanta’s Jacksonville Branch. Prior to joining the Fed in 2010, she was an Instructor of Economics and Director of the Center for Economic Education at Auburn University Montgomery and a high school economics teacher. A native of Auburn, Alabama, Lesley holds a B.A. in Economics and Foreign Language and a M.S. in Economics from Auburn University.

BARBARA O'NEILL holds the rank of Distinguished Professor at Rutgers University, and is Rutgers Cooperative Extension's Specialist in Financial Resource Management. She also provides national leadership for the Cooperative Extension programs *Investing For Your Future* and *Small Steps to Health and Wealth*TM. A certified financial planner®, Dr. O'Neill received her Ph.D. in family financial management from Virginia Tech and has written over 1,700 consumer newspaper articles and over 160 articles for professional publications. She has also received over three dozen awards for program excellence and over \$1.2 million in external funding to support her financial education programs and research.

NINOS MALEK is a Professor of Economics at De Anza College in Cupertino, California. Dr. Malek is also an Economics Lecturer at San Jose State University, where he has been nominated and selected as a finalist for *Outstanding Lecturer*. He taught Economics and Advanced Placement Economics at Valley Christian High School in San Jose, California, for 14 years. Ninos earned his B.A. and M.A. in Economics from San Jose State University. He earned his Ph.D. in Economics from George Mason University. Dr. Malek has been recognized for his teaching excellence at both the high school and college level. He placed second in the *Economics Communicators Contest* in Las Vegas, Nevada, in 2008 sponsored by the Association of Private Enterprise Education. Dr. Malek has led several economics teacher workshops and student seminars for the Fraser Institute, Canada's top public policy think-tank. Ninos has also been a featured speaker for the Gus A. Stavros Center for Economic Education at Florida State University (2014), California Council for Economic Education/Bay Area Financial Education Foundation, and the California Association of School Economics Teachers. He has also written several opinion pieces for Learn Liberty, Foundation for Economic Education, and Ludwig von Mises Institute.

TAWNI HUNT FERRARINI is the Robert W. Plaster Professor of Economic Education at the Lindenwood University's Hammond Institute. For twenty years at Northern Michigan University she served as the Sam M. Cohodas Professor of Private Enterprise while helping direct the Center for Economic Education and Entrepreneurship. She served as the 2015 President of the National Association of Economic Educators and has received several national awards in economic education. Tawni is co-author of *Common Sense Economics: What Everyone Should Know About Wealth and Prosperity* (2016, St. Martin's Press), *Economic Episodes in American History* (2019, Wohl Publishing), and *Teachers Can Be Millionaires, Too* (2019, TBD). Her teaching, research, and service focus on how to take complex economic ideas and models and effectively bring them to the masses through courses, publications, and curriculum materials. Her reputation as a dynamic speaker on economic topics brings her around the globe. She is widely known for exciting diverse audiences about how sound economic reasoning can help them take firm steps toward living personally rewarding lives. She earned her doctorate from Washington University, where she studied under the 1993 Nobel laureate Douglass C. North, and has a Bachelor of Arts degree in mathematics from Southern Illinois University - Carbondale.

JOHN HILSTON, a former project/industrial engineer, earned his bachelor's degree in Industrial Management from Grove City (PA) College, his master's degree in Economics from Cleveland (OH) State University, and his doctorate in Higher Education Leadership from University of Central Florida. John was recently honored with the Leavey Award for Excellence in Private Enterprise Education. Leavey Award recipients are chosen by the Freedoms Foundation at Valley Forge, PA. He has taught Economics and American History for Eastern Florida State College since 2007.
